T1 - 6m high x 5m spread - remove 2 stems, crown reduce remaining stems and raise to 2m. T2 - in decline, fell to ground level. T3 - 6m high & 3m spread -remove 2 stems and reduce height/spread of remaining 2 stems from 6m to 3m.
